Compared to having the situation pre-TPRP, most measures have placed barriers in the way of switching. The idea that regulation provides assurance to consumers is unlikely to work: the products are regulated to look like cigarettes and therefore have implied risks that are associated with cigarettes and their appearance.

9. Do you consider the restrictions on e-cigarette advertising to be an effective way to discourage young people and non-smokers from using e-cigarettes?

It is not an effective method for two reasons: (i) it may inhibit adolescent smokers from switching or not initiating smoking. (ii) it may inhibit adults from switching and it is not targeted to advertising that attracts youth. The advertising of e-cigarettes is functionally equivalent to stop-smoking advertising and its restriction is a regulatory protection of the cigarette trade.

#### Novel tobacco products

The treatment of tobacco and related products should be based on risk and be proportionate. UK regulations primarily differentiate between tobacco and non-tobacco products. The key distinction should be between combustion and non-combustion products.
